Town Mayor Cllr S. Sheath welcomed Rev. Mark Williams from the Parochial Church Council of Christ Church Sandown to the meeting to talk about Breakfast in the Bay. (Cllr Quirk declared an interest having been a school governor).

The breakfast club has been running since January and have grants from Sandown Rotary, southern water, Lake parish council & Sandown Town council. All the monies go on food for the children. The breakfast club is run by volunteers & they have funding for two years. 2 of the 5 schools in Shanklin partake in the scheme which runs during term time only. The school allows volunteers to use their kitchen. During the week the children receive cereal, toast, on Fridays they have sausages and bacon. There has been a noticeable difference in some of the children in the scheme they have come along leaps and bounds. The Town Mayor thanked Mark & his colleague for attending and they left the meeting.

Mark Birch and the lifeboat team thanked the students for their generosity and enthusiasm highlighting the importance of community support in helping to save lives along the coast.
